CIRCULAR

ISSUING LIST OF AREAS BANNED FROM AQUATIC PRODUCTS EXPLOITATION WITHIN A DEFINITE PERIOD IN A YEAR

Pursuant to the Law on Fisheries of November 26, 2003;

Pursuant to the Decree No. 01/2008/ND-CP, of January 03, 2008 of the Government regulating functions, duties, powers and organizational structure of the Ministry of Agriculture and Rural Development; the Decree No. 75/2009/ND-CP of the Government amending and supplementing Article 3 of Decree No. 01/2008/ND-CP, of January 03, 2008 of the Government regulating functions, duties, powers and structure of Ministry of Agriculture and Rural Development;

The Minister of Agriculture and Rural Development issues the list of areas banned from aquatic products exploitation within a definite period in a year as followed:

Article 1. To issue with this Circular the list of areas banned from aquatic products exploitation within a definite period in a year.

Article 2. This Circular takes effects 45 days after its signing date and annuls the Annex 4 regulating the list of restricted areas for aquatic products exploitation within a definite period in a year issued together with the Circular No. 02/2006/TT-BTS of March 20, 2006 guiding the implementation of the Decree No. 59/2005/ND-CP of May 04, 2005 of the Government on conditions for production and trading of some fisheries industry; and the Annex amending and supplementing Annex 4 issued together with the Circular No. 62/2008/TT-BNN of May 20, 2008 of the Minister of Agriculture and Rural Development on amendment and supplementation of a number of provisions of the Circular No. 02/2006/TT-BTS.

Article 3. Chief of the Ministry Office, Director General of the General Department of Fisheries, Presidents of People's Committee at all levels, Heads of relevant agencies, organizations and individuals engaging in fisheries activities in Vietnam shall be responsible for implementation of this Circular./.
